**1. ANNOUNCEMENT:**

The **TOWNSVILLE MOTORCYCLE CLUB**, hereafter called the PROMOTING CLUB will conduct Motocross Closed to Club Events for juniors and Seniors at the **Woodstock Track** as per Permit Applications applied for, (Dates subject to change)

**2. JURISDICTION:**

- 2.1. The abovementioned meeting has been authorised by MQ who has issued the Motorcycling Australia Permit Number 40431 and is open to holders of current Motorcycling Australia National, Club, Mini and One Meeting Licences (OML to junior riders if they hold a current JCP Log Book), who are full financial members of the Townsville Motorcycle Club.
- 2.2. The meeting will be held in accordance with the current Manual of Motorcycle Sport General Competition Rules (GCR's), these Supplementary Regulations, and any Final Instructions approved by MQ.

**BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.**

**3. ENTRIES:**

- 3.1. Entries open forthwith and will be accepted on the day of the meetings, before the close of sign on.
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Club, if such retention is approved by MQ.
- 3.3. Only entries received on the official Entry Form that are accompanied by the correct fee will be accepted.

**4. INSURANCE:**

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.

**4.3. IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.**

**5. MEDICAL SERVICES:**

**QAS vehicle and Officers will be on site from commencement of meeting to 15 minutes after racing has finished.**

**6 ENTRY FEE:**

- 6.1. **Junior \$30. Senior \$35. Extra class \$10 per class**
- 6.2. Payment by cash/cheque only. **ANY FEES FOR DISHONOURD CHEQUES WILL BE THE RESPONSIBILITY OF THE ENTRANT.**
- 6.3. Cheques and Money Orders are to be made payable to the **Townsville Motorcycle Club Inc.**

*The club reserves the right to combine classes on the day due to numbers.*

*Club Grading's may be done twice per year depending on numbers, new riders to the club day may be graded on the day. All holders of MA National licences must ride at the minimum of their National Grading or above.*

## 8 AWARDS AND PRIZEMONEY:

*Ribbons/trophies to third at the end of each club day to classes entered. 50cc Demo will receive participation ribbon/trophy as no points are awarded. Unlimited Class will not receive award as this class is not scored.*

*All points for club days accumulate and go in for the end of year awards. The awards/perpetual trophies remain the property of the TMCC and are to be returned to the club at the end of each year. 50cc Demo riders who step up to a competitive class during the year are not eligible to receive a participation trophy at the end of the year.*

*To be eligible for end of year trophies riders must have competed in 3 out of 5 club days or 60% of designated club days for 2012.*

## 9 ENTRIES TO CONSTITUTE A CLASS:

To constitute a Class, the number of contestants entered and competing in each Class shall be no less than **SIX (6)**

Should there be insufficient entries in any Class of Competition, the decision to run or cancel the Class, or to combine events and re-distribute any awards, will be at the discretion of the club, subject to MQ approval. Some junior classes maybe combined.

## 10 RACE FORMAT:

**10.1 SIGN ON/SCRUTINEERING – 7AM -8AM** (all riders are advised to walk the track and inspect once their bike has been scrutineered.

**10.2 RIDERS BRIEFING 8AM**

**10.3 PRACTICE – Immediately following Riders Briefing** (The maximum number of riders for practice will be 125% of the number of start gates.)

**10.4 RACING STARTS AT THE END OF PRACTICE. RACE ORDER WILL BE ANNOUNCED AT RIDERS BRIEFING.**

**10.5 Times may change owing to circumstances at the time.**

## 11 MACHINES AND RIDERS:

11.1 All machines entered must comply with the current GCR's for **MOTOCROSS** Competition.

11.2. Multiple entry of the one Machine in the same Class of Competition is not permitted.

11.3. **Riders must advise in writing any change of machine before entering the track. Failure to do so will result in no points awarded for this rider in the race. Machine must pass examination before re-entering competition. Replacement bike must be eligible for the class entered. All riders must wear back numbers or may not be scored.**

11.4. Helmets are mandatory. All persons including officials using any bike, trike or quad at an event must be wearing a properly secured helmet.

## 12 RIDING NUMBERS:

**12.1** Wherever possible competitors will be allocated their registered riding number, (the number on the back of their licence, but the promoter does reserve the right to allocate numbers at their discretion. National licence holders have precedence over club licence holders when it comes to number allocation.

**12.2** All Number plates on all Machines must comply with GCRs.

**12.3 BACK NUMBERS:** all competitors must wear a legible machine identification number on his/her back in contrasting colours. Any rider that does not display an approved back number whilst competing **MAY NOT** be awarded points for that race.

**13 GRID POSITIONS:**

Positions will be drawn if necessary; otherwise an orderly manner is required to obtain grid position.

**14 RIDERS BRIEFING:**

A Riders Briefing will be held prior to the commencement of racing and ALL Competitors **MUST** attend the Riders Briefing. Riders Briefing is a **NON Smoking Area**.

**15 DRUG AND OR ALCOHOL TESTING:**

**15.1** All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency.

**15.2** If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020506. When drug testing takes place, the payment of prize money may be delayed at MQ discretion until the results of the tests are known.

**15.3** All alcohol is banned from being consumed in the pit area and pit paddock during racing. Any person/s found consuming alcohol in these areas **WILL** be asked to leave the meeting with their rider/s.

**15.4** For the purposes of Drug and Alcohol Testing the commencement of the meeting will be deemed to be 7.00am with the completion of the meeting for participant being when the participant has vacated the venue.

**16 CODE OF CONDUCT:**

All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law - CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behaviour at all Motorcycle Race Meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

**17 CIRCUIT DESCRIPTION:**

As per current Track Licence.

**18 STARTS:**

*All starts will be by self-penalizing gates. A maximum of forty (40) will be used for motocross.*

**19 RACING:**

*Each class will have a minimum of 3 laps practice immediately following riders briefing, 1<sup>st</sup> lap will be under yellow flag.*

*Each class will have a MINIMUM of 4laps per race with 3 rounds on the designated track for the day. 50cc Demo will run on a shortened track.*

*Classes of the same capacity may be run together but pointed separately as per grade.*

**20 NOISE:**

Random Noise Testing will be conducted as per current GCRs.

**21 SPECIAL NOTES AND WARNINGS:**

**Snr Unlimited class includes 165cc – 510cc 2/- & 255cc – 633cc 4/- and is open to the first forty (40) senior entries received, substitutes will be at discretion of Race Secretary if a rider withdraws.**

**250cc 4/- can only be ridden in senior lites class – NOT in open class.**

**22 MACHINE EXAMINATION**

This will be conducted next to the canteen in the designated area. All competitors must present themselves with machines, helmets, back numbers, and licence and membership cards. Failure to do so will mean exclusion from the meeting. Junior riders must present logbooks.

**23 FLAG MARSHALLS**

**Each competitor is required to have a representative for ALL club days. Upon request that representative must be able to act as Flag Marshall, Official or Helper. Failure to supply a representative upon request WILL mean exclusion for the rider/s.**

**FLAG ROSTER BOARD MUST BE FILLED FOR ALL THREE ROUNDS BEFORE RACING COMMENCES FOR THE DAY.**

**24 GUARDIANSHIP FORMS**

Riders 18years and under must have a guardianship form signed by their parents or guardians if not accompanied by them on the day of racing. If this form is not filled out and handed in at sign on, that rider will not be riding – no exceptions.

NO DOGS ALLOWED (GUIDE DOGS ACCEPTED)

NO FIRECRACKERS, FIREWORKS, PUSHBIKES, SCOOTERS OR PIT BIKES ALLOWED IN PIT AREA.

RIDING OUT OF PIT AREA IS PROHIBITED, IF CAUGHT RIDING OUTSIDE OF PIT AREA YOU WILL BE ASKED TO LEAVE IMMEDIATELY – FOR TESTING OF BIKES CONTACT CLERK OF COURSE IN FIRST INSTANCE.

## CONTRACT TO PARTICIPATE IN THE TMCC CLOSED TO CLUB MOTOCROSS 2012

**WARNING! THIS IS AN IMPORTANT DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS AND OBLIGATIONS, PLEASE READ IT CAREFULLY AND DO NOT SIGN IT UNLESS YOU ARE SATISFIED YOU UNDERSTAND IT.**

1. I THE UNDERSIGNED (see below): [Insert Name]

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

### 2. DEFINITIONS

- In this declaration:
- a) "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
  - b) "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
  - c) "MA" means Motorcycling Australia Limited;
  - d) "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
  - e) "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
  - f) "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

### 3. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

I ACKNOWLEDGE that:

- a) motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
  - i) that I may be injured, physically or mentally, and may be killed;
  - ii) that my machinery or equipment may be damaged, lost or destroyed;
  - iii) that competitors may ride dangerously or with a lack of skill;
  - iv) that track or event conditions may be hazardous and may vary without warning or predictability;
  - v) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
  - vi) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
  - vii) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
  - viii) that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
- b) the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- c) to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- d) have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

### 4. WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are:

- rendered with due care and skill;
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form. **NOTE:** The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of the clause 3, "the Supplier" shall mean and include the Indemnitees.

### 5. INDEMNITY AND RELEASE GIVEN TO ORGANISERS

IN CONSIDERATION of the acceptance of me as a participant in the Meeting:

- a) I AGREE TO INDEMNIFY AND KEEP INDEMNIFIED to the full extent permitted by law the Indemnitees and each of them in the following manner:
  - i) that I participate in the meeting at my sole risk and responsibility;
  - ii) that I accept the Venue as it stands with all or any defects hidden or exposed;
  - iii) that I indemnify and hold harmless the Indemnitees, their respective servants, agents, officials and competitors against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
- b) I AGREE TO RELEASE to the full extent permitted by law the Indemnitees and each of them from all liability to me for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, psychological trauma, death, property damage or infringement of third party rights or otherwise) that arises as a result of any act, matter or thing done, permitted or omitted to be done by me or which is in any way connected with my presence at or involvement in the Event.
- c) The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable terms or conditions in respect of the Event.
- d) A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

### 6. MEDICAL

I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

### 7. PRIVACY

I hereby consent to the collection of my personal information by the Promoter/Event Organiser, MA and the SCB in connection with my involvement at the Event and the use and disclosure of my personal information by Event Organiser, MA to other agencies and officials associated with the Event for the purposes of conducting and managing the Event. I understand that I may gain access to my personal information held by contacting MA at 147 Montague St, South Melbourne, Victoria, 3205. I understand that if I do not provide the personal information requested above that I may not be permitted to participate in the Event.

### 8. PERSONAL HEALTH INFORMATION

I hereby agree with MA and the SCB that in consideration for my participation in the Event that MA and the SCB may receive, collect, store and use personal health information about me in the manner set out below:

- a) I ACKNOWLEDGE that:
  - i) If I am injured, become ill or die at or following the Event the party listed at Item 8 in Schedule 1 in addition to any hospital at which I am treated (together "my Carers") will have health related information about me in their possession, power and control relating to me which is subject to obligations imposed by the Privacy Act ("my Information") and the Privacy Act is intended to protect my personal information;
  - ii) MA and my SCB wish to collect my Information for purposes that include their risk management programs, evaluating and improving the safety of MA and SCB events and of the Meeting organisers and

facility providers of MA / SCB permitted events, and generally to reduce the risks to persons engaged in motorcycle sport; and

- iii) It is reasonable for MA and my SCB to collect, store, use and disclose my Information in accordance with clause 11(a)(i) above and in the manner set out in clause 11(b).

- b) IN CONSIDERATION of my acceptance as an entrant in the Meeting I consent and agree that MA and my SCB:
  - i) may collect and store any of my Information, including obtain my Information from third parties including my Carers;
  - ii) may use any information collected in accordance with this clause for any purpose consistent with creating safer competition in motorcycle sport and events held by or in conjunction with MA, my SCB, or with an MA or SCB permit;
  - iii) may disclose my Information to third parties provided such disclosure is reasonably intended to be used for the purpose of improving safety at events held by or in conjunction with MA, or with an MA permit provided any such information is held by MA or my SCB in accordance with the MA Privacy Policy.
- c) I irrevocably authorise MA and my SCB and hereby appoint MA and my SCB as my lawful attorneys to collect from my Carers, and I hereby direct my Carers to provide to MA or my SCB upon request being made by MA or my SCB, any of my Information including but not limited to any information concerning any incident or event causing or contributing to or resulting from any injury, illness or death to me, the details of any diagnosis and prognosis provided to me by my Carers (or any party with the knowledge of any of my Carers), and any other matter to the knowledge of my Carers that might reasonably be considered to be requested by MA or my SCB for the purpose of improving safety at MA and SCB events.

### 9. POLICIES AND REGULATIONS

- a) I acknowledge, understand and agree that it is a condition of my participation in the Event that I agree to be bound by, and subject to, the rules, regulations and jurisdiction of MA as amended from time to time. Copies of all MA rules, policies and regulations are available by contacting the MA office.
- b) All participants are bound by the MA anti-doping policy and thus understand they may be subject to drug testing. Testing conducted by the Australian Sports Anti-Doping Authority (ASADA) is in accordance with the ASADA Act and the National Anti-Doping Scheme. This involves the taking of a sample (any human biological fluid or tissue whether alive or otherwise, or any human breath) for the purpose of detecting the use of a Prohibited Drug or Doping Method. Any participant infringing MA's policy or refusing a drug test may be disqualified or otherwise dealt with in accordance with the terms of the Club anti-doping policy.
